LANAIC Human Relations Consultant vacancy updates

Alexandra shared that she is working closely with the Human Resources Division of the Executive Office to identify the most suitable item to support the LANAIC as well as how best to run the respective exam.

Natives in LA COVID Response Working Group

Commissioner Garcia provided brief updates about the Working Group. Sharing that the Working Group still meets bi-weekly to share about agency updates as well as to respond to the emergent needs of the community.
