Call to Order & Land Acknowledgment

Chairperson Cheri Thomas called the meeting to order at 6:31 P.M and read the Los Angeles County Land Acknowledgment.

Action Items

Review & approval of the Unapproved June 20, 2023, Los Angeles City/County Native American Indian Commission (LANAIC) Meeting Minutes

A motion was made by Commissioner Andrea Garcia and seconded by Commissioner Rudy Ortega, Jr. to approve the unapproved June 20, 2023 LANAIC Meeting minutes as presented. The motion passed.

Review & take possible action directing the LANAIC Executive Director to explore options for sponsorship of the 2023 Indigenous Peoples Day Event by an elected official(s)

Alexandra Valdes shared that the 2018, 2019 and 2022 Indigenous Peoples Day events were sponsored by former LA City Councilmember O'Farrell and that this type of event requires the sponsorship of an elected official. Commissioner Shawn Imitates Dog stated that he does not believe that the LANAIC has the manpower to hold an event. He also shared that Indigenous Pride LA reached out to him because they are interested in doing a joint event. He added that he believes the LANAIC should do something small and build on it in the future. Commissioner John Only A Chief stated that this motion would be a step in the right direction and that the (2023 IPD and Native American Heritage Month) ad hoc committee could figure out what the available resources are. Commissioner Chrissie Castro stated that she recommends sending a memo to the Mayor's Office. Commissioner Castro stated that it would be great if we could institutionalize everything so that they could do it each year. She also stated that the LANAIC doesn't have the infrastructure to hold large events. Commissioner Andrea Garcia stated that she agrees with sending a letter to the Mayor's Office which includes other documented needs.



A motion was made by Commissioner John Only A Chief and seconded by Commissioner Rudy Ortega Jr. to direct the LANAIC Executive Director to explore options for sponsorship of the 2023 Indigenous Peoples Day Event by an elected official(s). The motion passed.

Presentations

County of Los Angeles Land Acknowledgement Toolkit and Training Resources (Desiree Martinez, President – Cogstone Resource Management & Ashley Dobson, Vice President – Avid Core)

Alexandra introduced the presenters and a brief overview of how they were solicited by the Department of Art and Culture to develop the County of Los Angeles Land Acknowledgement Toolkit and Training Resources. Desiree Martinez stated that the team will be working with the County and participating tribes to develop toolkits, resources, and directs about histories about local tribes, and guidance on how to implement the County adopted land acknowledgement. Ms. Martinez also shared that all materials will be visually appealing, with content that is accessible to a wide range of audiences and how to implement the tools without causing further harm to local tribal communities. Ms. Martinez stated that the team will reach out to all 22 tribes from the AB 52 State list for invitations to participate in the project.

Commissioner Andrea Garcia asked Ms. Martinez if the material will be owned by the County, because as a County employee there is not a lot of accessible media content. Ms. Martinez stated that there will be a media release, and the images taken for the project will be available for County use. Commissioner Chrissie Castro recommended the inclusion of a self-assessment in the toolkit for employees and County entities to utilize to help ensure it is not a performative act. Commissioner Cheri Thomas asked if the LANAIC can be advised of the groups who choose to participate and those who choose not to participate.

Cherokee Nation's Request to Seat their Delegate in the United States House of Representatives (Cynthia M Ruiz, Council Member – Tsa-La-Gi & Laurie Doctor, Council Member – Tsa-LA-Gi)

Cynthia Ruiz presented an overview of the Tsa-La-Gi's call for support to the LANAIC regarding the enforcement of a treaty agreement that allows a Cherokee Nation Delegate in the United States House of Representatives. Commissioner Rudy Ortega Jr. asked Ms. Ruiz if she could submit a list of all the entities that have provided support. Ms. Ruiz shared that she would send a list to Alexandra.



Discussion Items

Review and provide edits on a draft letter from the LANAIC to the Board of Supervisors Recommending they support the seating of the Cherokee Nation's delegate to the United States House of Representatives

Chair Thomas shared that she drafted a letter for the LANAIC to discuss and edit. The letter would advocate to the Board of Supervisors that they support the seating of the Cherokee Nation's delegate to United States House of Representatives. Alexandra shared that she would be requesting additional edits via email by August 1 and then will be including the final draft letter for the body's consideration for adoption at the August meeting. Chair Thomas asked Commissioner Rudy Ortega Jr. if he recommends adding as an attachment the list of supporters that Ms. Ruiz will be submitting to Alexandra. Commissioner Ortega Jr. confirmed that he does recommend the addition of a list of supporters as an attached to the letter.

Chair's Report

LA Metro 2023 Native American Heritage Month TAP Card Updates

Chairperson Cheri Thomas shared that Metro has been expanding their series of community outreach cards. She shared that there is no other update at the moment.

Executive Director's Report

Upcoming LANAIC Executive Committee Elections

Alexandra provided a reminder that the LANAIC Executive Committee members serve two-year terms and that there will be elections at the November 2023 meeting to select the incoming Chairperson, Vice Chairperson, Treasurer and Secretary. The new Executive Committee will begin their terms in January 2024 and serve through 2025.

FY22-23 LANAIC Annual Report Updates

Alexandra reminded the Commission that the FY22-23 LANAIC Annual Report is due to the Board of Supervisors by September 30. She plans to include the final draft for possible adoption by the Commission at the September 19 meeting.

Feather Alert Town Hall Updates

Alexandra shared that she is working with Assemblymember Ramos' Office and California Native Vote Project staff to firm up logistics for the Feather Alert Town Hall event scheduled for fall 2023.

Erasure Video Updates

Alexandra shared that former LANAIC Creative Strategist will be editing his short video Erasure to include the County of Los Angeles adopted land acknowledgement per the request from the LANAIC to Department of Arts and Culture Director Kristin Sakoda on June 20, 2023.

Dear Board of Supervisors,

I am sending this letter on behalf of the Los Angeles City/County Native American Indian Commission (LANAIC). The purpose of this letter is to recommend that the Los Angeles County Board of Supervisors support the seating of the Cherokee Nation's delegate to the United States House of Representatives per the 1835 Treaty of New Echota.

In 1835, the Cherokee Nation and United States signed the Treaty of New Echota. The treaty forcibly removed the Cherokee from their homelands, which led to over one-quarter of the Cherokee Nation perishing on the "Trail of Tears." That same document, however, also guaranteed the tribe a delegate to Congress. For almost 200 years, the U.S. House of Representatives has failed to act or honor this promise. In 2019, Chief Hoskin Jr. nominated Kim Teehee as the Cherokee Nation delegate and committed to the effort of finally demanding Congress live up to its agreement. Thousands have acted by calling on Congress to vote to the seat the Cherokee Nation delegate. Historic progress has been made, including in November 2022, when the U.S. House Rules committee held a congressional hearing to discuss the issue.

The Treaty of New Echota has no expiration date. It's time for the U.S. government to fulfill its promise and uphold its legal obligation to guarantee the Cherokee Nation a delegate to Congress. We respectfully ask that the County of Los Angeles Board of Supervisors authorize advocacy for this critical representation and add this advocacy position to the County of Los Angeles Federal Legislative Agenda.
