The August 31, 2023, meeting of the Los Angeles City/County Native American Indian Commission (LANAIC) Homelessness Subcommittee was held at the County of Los Angeles Department of Arts and Culture, 1055 Wilshire Blvd Suite 800, Los Angeles, CA 90017.

CALL TO ORDER

Chair of the Homelessness Subcommittee Garcia called the meeting to order at 3:00 P.M.

Discussion was also had in relation to a previous LANAIC meeting in which the Mayoral Appointees discussed writing a possible letter to Mayor Bass, outlining priorities for the short term which include homelessness priorities. It was decided that due to the uncertain timeline of a possible letter from Mayoral appointees, and the urgency of the current request, that the proposed letter today would still be prioritized for action at the September LANAIC meeting.

7.3 Discuss re-titling of the Report on UNDRIP Framework and Indigenous Housing

Rights and the report release strategy

Current status of the report: With graphic designer. Subcommittee needs to submit to graphic designer quotes for 'call out' within the report, as well as an inside cover with Land Acknowledgement, authors, and LANAIC information. It was also flagged that we need to get permission from the Housing Collaborative to include a brief description of them in the report. A title was not finalized during this meeting, however the subcommittee did review the products developed by Swell outlining the report release strategy. This includes draft press release, draft emails, and social media copy.
