Commissioner Dawn Jackson asked if there is a limit to the number of allowable absences. Alexandra Valdes stated that there is no limit to the number of allowable absences. She also stated that commissioner attendance is submitted monthly to commission services and commission services only records attendance as 'present' and 'absent'.

Vice Chairperson Mark Villasenor stated that attendance could be recorded quarterly. Commissioner John Only A Chief stated that as a body the LANAIC should come up with the process and not have to have County counsel review. Commissioner Only A Chief also stated that the bylaws are being sidelined and they should be number one. Chairperson Shawn Imitates Dog stated that the topic of excused versus non-excused absences has come up several times and he asked Alexandra how other commissions address the matter. He also stated that he wants to make sure that whatever is reflected in the minutes should be tight and good documentation is important.

Alexandra Valdes stated that the LANAIC does have to adhere to County rules. Commissioner Only A Chief stated that the LANAIC is adhering to County rules by following the bylaws. Commissioner Dawn Jackson asked if all Department of Arts and Culture commissions have adopted absentee excuses. Heather Rigby stated that there are two commissions within the Department of Arts and Culture, and the Arts Commission follows the practice regarding commissioner absentee excuses.

Discussion Items

**Discuss feasibility of 2024 Native American Heritage Month reception at LA City Hall’s Forecourt on November 1, 2024**

Alexandra Valdes stated that there was an ad hoc meeting with LA Council District 7 (CD7). She shared that at the meeting CD7 stated that they connected with Los Angeles City Department of Cultural Affairs and determined that there is no way to move forward with a request for proposals solicitation as the LANAIC had recommended for an event coordinator to plan a

reception at LA City Hall's Forecourt by November 1, 2024. Alexandra also stated that from the City's perspective they had committed to securing the location and that the LANAIC would be able to fundraise for the event. However, this did not take into consideration that the LANAIC is a County body and must follow County policies in regards to fundraising and contracting.. Further, Alexandra stated that it is uncommon to ask the County to provide resources for a City event.

Chairperson Shawn Imitates Dog stated that it is unfortunate that the City is going back on what they said because it throws a wrench in the event and that he would like to follow up with the City if it would be possible to still hold the event if they could connect a community organization directly with the City. Heather Rigby stated that the ask is to go back to the City and see if they would be willing to work directly with an organization. Heather also stated that a work around is not typically what you would want to do because it may appear like the LANAIC is circumventing policies. Commissioner Mona Morales Recalde stated that the LANAIC is a stakeholder in facilitating activities. Chairperson Imitates Dog asked in the LANAIC needs to go back to the City. Alexandra stated that she recommends that the LANAIC should go back to the City if they want to discuss the matter in more detail because there was not a member from the City present to answer questions. Chairperson Imitates Dog stated that the LANAIC wanted to get around the red tape. Commissioner Morales Recalde stated that she believed that the LANAIC should reach out to CD7 and get something in writing.

### **Discuss taking possible action recommending LA City Council support a Kuruvungna Sawtelle District in the City of Los Angeles**

Commissioner Mona Morales Recalde stated that LA City is looking to rezone in the Sawtelle district and that the district will be renamed to represent the first people of Los Angeles. She also shared that the draft letter that she submitted shows that the LANAIC shows support to establish this action. Commissioner Dawn Jackson asked if there is any opposition to the ask. Commissioner Morales Recalde stated that there has not been any opposition that she has heard of and that renaming does require 500 signatures from the neighborhood and there is a group that is currently gathering signatures. Vice Chairperson Mark Villasenor asked if the Los Angeles Unified School District owns the lot or if Commissioner Morales Recalde's tribe is trying to acquisition. Commissioner Morales Recalde stated that one day that is the goal but they are not putting that in their heads first because they would not disrupt the LAUSD property. She also stated that the purpose is to have a cultural center, green space and a space for medical providers and that would require rezoning, which is what the draft letter is about.

Commissioner Rene' Williams asked if the item is for Commissioner Morales Recalde's tribe. Commissioner Morales Recalde stated that the item is community based. Commissioner Rich Toyon asked if the proposed zone change would only be a change in name. Commissioner Morales Recalde stated that the current zoning is residential, and the zone change would include a shift to hybrid zoning. Commissioner Williams asked if there is more information about this item besides the map that was provided. Commissioner Morales Recalde stated that there is more information in the packet that was provided and that there have been some plans for housing.

#### **Care First Community Updates, Tencha Chavez (LANAIC CFCI Alternate Designee)**

#### **County Process Updates, Heather Rigby (Chief Deputy, LA County Department of Arts and Culture)**

Heather Rigby stated that Brown Act structures and supports similar to the tools used by the Arts Commission create efficiencies to ensure that there is enough information for the Chairperson to decide if something is appropriate to put on a meeting agenda. Heather shared a packet and stated all items must be submitted when requests are made to the Chair. Heather stated that once requested items are submitted with all of the required information, the Chair works with the Executive Director to construct the meeting agenda. Heather shared that this process discourages sidebars and other discussions outside of Brown Act rules.

Vice Chairperson Mark Villasenor asked if the form must still be filled out for items that come up organically. Chairperson Shawn Imitates Dog stated that the process is to help him get data organized. Commissioner John Only A Chief asked how this process impacts public comment and if the public must also follow this process. Heather stated that members of the public cannot request agenda items and that public comment is maintained separately. Commissioner Only A Chief asked Shawn if this is a process that he supports. Chairperson Imitates Dog stated that this was the process that was used for the last meeting and it was very helpful and that the process is to make sure that all information is complete and accurate. Alexandra Valdes stated that this process also ensures that agenda items reflect what the person is requesting.

### Chair's Report

#### **Recap of meeting with City of Long Beach staff about proposed Native American Commission**

Chairperson Shawn Imitates Dog stated that the meeting with City of Long Beach staff was informal to learn about the origins of establishing the proposed Native American Commission and it sounds like it will likely not be moving forward. Chairperson Imitates Dog stated that the City of Long Beach staff were interested in how to support their internal government infrastructure. Alexandra Valdes stated that all governments in California are experiencing budget cuts and it does not look like it will be going on their next budget. Chairperson Imitates Dog stated that the LANAIC wanted to know if there is a service that we are not providing and that does not look to be the case. Commissioner Mona Morales Recalde asked if the LANAIC should follow up with the council member that made the recommendation. Alexandra stated that through council action the commission would be advisory.

Kuruvungna Gabrielino Tongva Springs and Native American Community:

i. Motion: Request that LAUSD expand the area of the Kuruvungna Springs into the adjacent vacant lot and structure, including identifying additional springs, rewilding the land, and advocating for funding and/or funding sources (J.Handal, M.Mejia-Lambert - Approved 13-0-0).

Justification: The Springs comprise an irreplaceable and invaluable ecological, cultural, spiritual, and historical treasure. Our West L.A. Sawtelle community is severely and disparately impacted by the lack of greenspace. Expansion of the Springs's area advances both environmental equity and helps preserve this sacred site for future generations.

ii. Motion: Request that Council District 11 support the Gabrielino Springs Foundation in obtaining funding for a Gabrielino Tongva led and curated museum of the history of the site by allocating official staff time and committing to provide letters of support and other documentation (J.Handal, M.Mejia-Lambert - Approved 13-0-0).

Justification: The Gabrielino Springs Foundation maintains tens of thousands of archeological artifacts and documents that comprise essential history of the peoples and lands of Los Angeles Basin from pre-European encroachment, through Spanish and Mexican occupation, to the present day. These collections represent essential Los Angeles history and must be preserved for generations to come.

iii. Motion: Request that the City of Los Angeles designate areas of West Los Angeles, Sawtelle as Indigenous Cultural Districts that embody the cultures, histories, and values of the American Indian, Native Alaskan, and Indigenous Communities (J.Handal, M.Mejia Lambert - Approved 13-0-0).

Justification: A common value amongst native, indigenous cultures is harmony with the Earth and all of its life. The Sawtelle area suffers from inequitable access to green, open and recreational spaces and the concomitant health hazards. Cultural Districts rooted in access to public, open, biodiverse spaces, serve both to honor the original caretakers of this land as well as to address a critical public health need.

iv. Motion: Request that the West Los Angeles Community Plan Update staff coordinate with the American Indian and Native Community to incorporate among its Community Benefits, culturally-effective community facilities, essential services, ceremonial space, and supportive housing (J.Handal, M.Mejia-Lambert - Approved 13-0-0).

Justification: The Sawtelle area encompasses a substantial share of multi-family housing in West Los Angeles, while suffering from a severe lack of access to open space, health services, and affordable housing. Prioritizing these needs in a culturally specific manner for the AIAN community would advance Environmental Justice, Public Health Equity, and the redressing of historical injustices in the West Los Angeles Community Plan.

v. Motion: Request that CD11 itemize the above requests in the district's budget plan, in order to allocate sufficient official staff time and resources (J.Handal, M.Mejia-Lambert - Approved 13-0-0).
