The July 16, 2024, meeting of the Los Angeles City/County Native American Indian Commission (LANAIC) Homelessness Subcommittee was held at the County of Los Angeles Department of Arts and Culture, 1055 Wilshire Blvd Suite 800, Los Angeles, CA 90017.

CALL TO ORDER

Chair of the Homelessness Subcommittee Garcia called the meeting to order at 5:31 P.M.

COMMISSIONER INTRODUCTIONS

Commissioners provided a brief check in.

PUBLIC COMMENT

No public comment was submitted.

ACTION ITEMS

A motion was made by Commissioner Williams and seconded by Commissioner Escoto to adopt and approve the minutes from the March 19th, 2024 Los Angeles City/County Native American Indian Commission (LANAIC) Homelessness Subcommittee meeting. The minutes were approved 3-0.

A brief summary was given about the presentation and the powerpoint was included in the meeting packet. It was suggested that in addition to the County cluster meeting, that the homelessness subcommittee chair follow-up with the City of LA housing and homelessness chief and deputy specifically about the budget request and voucher conversation.

7.3 Discuss pending reports

Chair Garcia shared the final design and social media copy. She stated that the UNDRIP report would be released before the next monthly subcommittee meeting via Instagram and email. The following organizations were specifically named as entities to share with: Illuminative, National Council of Urban Indian Health, Urban Indian Health Institute, and Native Americans in Philanthropy. It was also suggested that the LANAIC consider rereleasing the report in October/November.

7.4 Discuss Fall 2024 research symposium with USC Homelessness Policy Research Institute

Chair Garcia shared that she has a working list of potential speakers and research teams to outreach to, and she will be getting help in that outreach. Additionally, it was suggested that outreach be done to Illuminative to ask whether they have relevant data; to Dr. Desi Small-Rodriguez, a native social demographer; to the New Zealand entity Whanau Ora; and to any one of the urban AIAN housing organizations in the U.S. A brief discussion about venues included consideration of Long Beach as a location and The California Endowment.

7.5 Role in future community convening
