#### CALL TO ORDER

Chair Dawn Jackson called the meeting to order at 6:02 P.M.

**EXECUTIVE DIRECTOR’S REPORT**

Alexandra connected with people from Legislative Affairs about the CSBG program. The Department of Social Services (DPSS), which also runs CSBG, shared a fact sheet to help. Congresswoman Norma Torres asked for success stories, and Alexandra said they could ask service providers for examples if needed—but it looks like that might not be necessary. There is a plan to cut CSBG funding completely in 2026, so the House will give updates then. Everyone’s watching what happens in September, when the Senate makes funding decisions. Hopefully, they will approve the rescission packet around September 15 or 16, and more updates will follow.

Commissioner Rene’ Williams asked whether a new Request for Proposals (RFP) would be necessary if funding for 2026 is secured, and Alexandra confirmed it wouldn’t be. Alex also shared that they’ve received three invoices covering April, May, and June. When Commissioner Williams inquired about the status of client services, Alexandra said everything was up to date and promised to include service numbers in the next meeting. Commissioner Williams expressed interest in seeing both demographic details and service counts moving forward.

**COMMISSIONER GENERAL COMMENTS ON NON-AGENDA ITEMS**

Vice Chairperson John Only A Chief shared that he attended a meaningful ceremony on Saturday, August 2, 2025, celebrating the return of land to the Gabrielino Tongva San Gabriel Band of Mission Indians. He share that the event featured a thoughtful presentation and was attended by notable guests, including the Mayor of San Gabriel and California House Representative Judy Chu. Vice Chairperson Only A Chief congratulated Commissioner Mona Morales Recalde, who played a significant role on behalf of her tribe in making this momentous occasion possible.

Security Number is, in a sense, Native American. Mr. Bailey also mentioned that he's formed a small political party and is working to get more people engaged. He noted that there's an upcoming initiative related to California potentially seeking to become its own country.
